How greedy can you get? 14 In 2010 voters approved \$186,000,000 in debt to "Provide classrooms" and in 2006 they approved \$298,000,000 in additional debt to "Build new and replace old classrooms". 12 Now they want another \$385,000,000 to do the same things all over again??? 13 Do schools really need upgrading every four to ten years? Have they even spent the \$186,000,000 from the 2010 bond or the \$298,000,000 from 2006? If not, why are they asking for more of your hard-earned tax dollars? Nuts, right? But that's what the District wants you pay for now, like they did in 2010. They issued bond 17 17 debt to purchase technology in 2010 that is now obsolete, but you are still paying for it. You deserved to know the full truth about measure L. 9 If you value school maintenance more than making principal and interest payments for 25-30 years, vote NO on Measure L. Remember, financing school projects via bonds, routinely double the cost of the 12 project.
