Argument in Favor of Measure RR

Vote Yes on Measure RR to prevent traffic congestion and save Caltrain, a vital lifeline for the Peninsula.

Caltrain is an essential part of the Bay Area's transportation network, but we're at risk of losing it due to COVID-19.
