If you were to call 911 right now for an ambulance, a crew of CAL FIRE 16 professionals would rush to your aid. But, come July 1st, no one knows who will 15 come, because these board directors decided that CAL FIRE's services were no 17 longer needed. The outstanding fire fighters and paramedics of CAL FIRE, who 17 have worked tirelessly for this fire district, may now have to leave by June 30th.

For a standalone department, approximately 31 full-time people need to be hired. The Including relief staff, the requirement goes over 40. As I write this, not a single is person has been hired or trained. After July 1st, should an emergency occur when the our fire stations are understaffed or unprepared, the nearest responders might is have to drive from Pacifica or over the hill. Such a delay, or worse, a mistake, from a crew hastily cobbled together, could become life threatening.

The decision of these board members to ignore the public's wishes was reckless. 13
