Argument in Favor of Measure

The cost of providing City services continues to escalate, and funds to sustain those services aren't keeping up with the increases.

Those City services are priorities such as police patrols, crime prevention, fire prevention, wildfire protection, pothole and street repairs, maintaining our parks and many facilities. These are basic needs that require a reliable source for ongoing funding.
