- 3. Applicant Recommendation's for Membership to Mr. Church
  - M. Levinson made a motion to accept all applicants as members and make a recommendation to Mr. Church by for approval approve, 2<sup>nd</sup> by 2<sup>nd</sup> by C. McCulloh, motion carried.
  - J. Irizarry confirmed Mr. Church intends to approve the appointments and send confirmation appointment letters to all the new members. (Bill Hershon, Fred Nisen, Ben McMullan)
- 4. Elections Staff Report
  - a. Update on 2017 Elections
    - i. June 6 Mail Ballot Election Town of Atherton (4,904 Voters)
      - Election Results were 61.40% YES (1,182 Votes) and 38.60% NO (743 Votes)
    - ii. November 2017 Election UDEL (Uniform District Election Law, consolidates municipal, school and special district elections)
      - J. Irizarry indicated that Mr. Church intends to hold a traditional Polling Place election as of this date.
    - iii. Budget allocations for the VAAC (J. Irizarry)
      - \$20,000 total for the FY 2017-2019
    - iv. Meeting with VCC (Future of California Elections Project), regarding SB 450
      - Orange County Board rejected the SB 450 proposal
      - Sutter and Sacramento Counties Board's passed SB 450 proposal
      - J. Irizarry discussed the preliminary draft and its status. He informed the VAAC that it will be shared with the VAAC as the draft plan. Mr. Irizarry confirmed that a core part of our process is to get input from various groups including the VAAC to complete the plan.
      - C. McCulloh shared concerns that in order to ensure a large turnout for the public hearing within the disability community we have to hold the meeting at conv times, preferably in the early evening. He also shared his experience with similar hearings that had low turnout and indicated giving as much notice in advance as possible to get the word out. We have to be mindful that many of the people we want to attend don't have easy access to computers. Word of mouth will be the best method to help drive turnout.

**ACTION ITEM:** C. McCulloh will reach out to Meals on Wheels to partner with them to help share Mobile Voting Center availability information.

- 6. Voter Accessibility Video
  - F. Nisen looked into funding for the video related to accessibility. He determined we need a timeline when we would like to have it completed, who it will be distributed to and if it will be exclusively related to SB 450 or more broad. We also need to think about the message the video will present. Will these be videos with a promotional message or instructional video regarding ways to approach voting under SB 450.

- The "How to" video may be best done by San Mateo County Elections staff.
