- During COVID, our high school campus offered direct access to testing and vaccine services, otherwise only accessible from distant locations. > 20
- Our two elementary schools provide community meeting and event space. 10
- A haven for sports & play, our campuses provide community access to little league & soccer fields, open gyms, and tennis courts. > 22
- Our high school is the primary polling location in our rural area. 12
