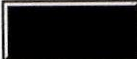

Project would demolish 161 existing residential units to construct 605 new residential units, a 625-space parking garage, 5,000 sf of retail/community space within three 5- to 13- story buildings, and a 1.5 million-gallon water tank. Project includes a General Plan and Development Code Amendment to create a Neighborhood Center Residential Overlay, which would allow neighborhood service uses, increased residential density, and increased building heights.
