

MARCH 3, 2020 PRESIDENTIAL PRIMARY ELECTION STATISTICS

At our most recent count, we had approximately 410,000 registered voters, but we expect that wide interest in the election sparked by mass media coverage will increase our registration numbers. There will be 37 ballot styles, each with 10 partisan variants and in three languages, for a total of 1,110 styles. Each of these parties will have a ballot paper color specific to that party. There will be 42 Vote Centers located throughout the County, 33 Drop Boxes locations, with 8 of these as outdoor locations open 24/7.
